MTCA Cleanup Regulation Update

Several advisory groups are providing input to Ecology's Toxics Cleanup Program regarding updates to the MTCA Cleanup Regulation. As part of this update, Ecology is also looking at cleanup portions of the Sediment Management Standards (SMS).

MTCA/SMS Advisory Group Meets April 26

The next meeting of the **MTCA / SMS Advisory Group** is Monday, April 26, 2010, from 9 a.m. to 3:30 p.m. at the Fabulich Conference Center in Tacoma, Room 104. Topics on the agenda include:

- Cleanup of contaminated sediments.
- Fish consumption rates.
- Method A cleanup levels.

Sediments Workgroup Meeting Cancelled

Please note that the Sediment Workgroup meeting scheduled for April 20, 2010 has been cancelled. The next meeting will be in May but a date has not yet been set.

The Sediments Workgroup completed its fifth meeting on March 16, 2010. Meeting materials are available on the Ecology website.

Ecology will be continuing discussions on how to clarify protection of human health from bioaccumulative contaminants and incorporate background concentrations when setting cleanup standards. Ecology will solicit input on the definition of Regional

Background and how the SMS rule and MTCA could be revised to feasibly implement a final cleanup with a low cleanup standard based on background.
