

INSTRUCTIONS FOR FORMS TO
ADD MOVANT AS ADDITIONAL PARTY

Attached are suggested forms for use to change the Court records to show the identity of new owner(s) of property for which the previous owner has filed a Court claim in this action (*State of Washington Department of Ecology v. James J. Acquavella, et al.*).

PROCEDURE

1. Print this document.
2. Complete the attached Motion to Be Joined as Additional Party (or similar form with the same information) and sign before a Notary Public – there are two places on the second page that need to be signed.
3. Mail or deliver in person the completed and signed form to the Yakima County Clerk's Office at the following address:

4. The Judge/Court Commissioner will sign an Order and have it filed for the record.
5. Notice of filing of the form and entry of the Order will be published in the monthly notice. If no objections to the motion and order are filed with the clerk within 30 days after publication, the Order will be deemed entered without objection. If there is an objection, the motion and order will be reconsidered at a hearing or other appropriate proceeding as the Judge or Commissioner deem advisable. The Order will be effective upon filing.
6. After the order becomes effective, all future notices will be mailed to both the original claimant and the additional party (movant)
7. You should attach to your motion a copy of the real estate purchase contract or deed setting forth the legal description for the property you have purchased.
