<p>CONSUMPTIVE USE CALCULATION:</p> <p><b>Indoor use:</b> One residential connection at 350 gallons per day (gpd) used continuously year round equates to 0.392 afy of water use, or:  <math>(350 \text{ gpd per connection}) \times (365 \text{ days}) \times (\text{one connection}) \times (1.0 \text{ ac-ft}/325,851 \text{ gal}) = 0.392 \text{ afy}</math>  Consistent with WAC 173-539A-050(3), 30% of domestic in-house use on a septic system is consumptively used, therefore:  Indoor consumptive use = <math>(0.392 \text{ afy}) \times (0.30) = \mathbf{0.118 \text{ afy}}</math></p> <p><b>Outdoor use:</b> The requestor proposes to irrigate 500 ft<sup>2</sup> of lawn and garden. Using a crop irrigation requirement of 18.11 in/yr (or 1.51 ft/yr) for pasture/turf near Cle Elum from the Washington Irrigation Guide and an application efficiency of 80%, the total outdoor irrigation water use is 0.022 afy, or:  <math>[(1.51 \text{ ft/yr}) \div 0.80] \times (500 \text{ ft}^2 \div 43,560 \text{ ft}^2/\text{ac}) = 0.022 \text{ afy}</math>  Consistent with WAC 173-539A-050(3), 90% of outdoor use is consumptively used, so:  Outdoor consumptive use = <math>(0.022 \text{ afy}) \times (0.90) = \mathbf{0.019 \text{ afy}}</math></p> <p><b>Total Use = 0.414 afy</b></p> <p><b>Consumptive Use = 0.137 afy</b></p>

**NARRATIVE DESCRIPTION OF PROJECT:**

The project is located in an unnamed drainage basin approximately 3 miles south of Cle Elum in a “yellow” area as noted in the current Suncadia Trust Water Right suitability map.

The requestor proposes to offset the 0.137 ac-ft of consumptive use for the project (one residential connection and 500 ft<sup>2</sup> of lawn and garden) with 0.137 ac-ft of mitigation water acquired from Trust Water Right No. CS4-05259CL@2sb7. During the irrigation season 0.072 ac-ft will be assigned to the USBR-Ecology Exchange Contract (Contract No. 09XX101700) to address flow impacts to the Yakima River from September 1 to March 31. In addition to the consumptive use of the project, Ecology will assign 0.024 ac-ft of the Trust Water Right to be managed within the Trust Water Right Program for instream flow purposes to benefit the Yakima River.

Review of the local area hydrogeology suggests that the proposed withdrawals will likely result in flow impacts to the Yakima River north of the subject property.
