I just got word that Listing ID# 42096 (Bear Creek, City of Redmond's Station 36) are based on samples taken from an MS4 manhole (city stormwater conveyance manhole). So is there an error in listing this segment? If I have it correct, these samples are not from the receiving water.

Hello Sinang,

I would be happy to provide the fecal coliform data that we have for stations 35 & 36.

Station 35 (trib at Avondale and 116th) was sampled quarterly from mid 2001 thru December 2003 and then in October 2004 we began, and continue, to sample there at monthly intervals (I collected a sample today as a matter of fact).

Station 36 (Avondale at 104th) was sampled quarterly from mid 2001 thru December 2003 and then in October 2004 we began to sample at monthly intervals there until September 2005. I am curious, since these samples were taken from an MS4 manhole (city stormwater conveyance manhole) I'm wondering if they should be included in 303d listings. But I also didn't see that listing on this website:

So maybe it was sampling results that were forwarded to you but were not meant to be included in the 303d listing. I have fecal coliform data from a number of other (small) tribs that outfall into that same stretch of Bear Creek if you are interested. I should be able to get the data

off to you by the end of the week. Let me know if you are for sure interested in the station 36 fecal data.
