<p>CONSUMPTIVE USE CALCULATION:</p> <p><b>Indoor use:</b> 1 residential connection at 350 gallons per day (gpd) used continuously year round equates to 0.392 ac-ft/yr of water use, or: Consistent with WAC 173-539A-050(3), 30% of domestic in-house use on a septic system is consumptively used, therefore: <b>Indoor consumptive use (CU) = 0.118 ac-ft/yr</b></p> <p><b>Outdoor use:</b> The requestor proposes to irrigate 500 ft<sup>2</sup> of lawn and/or garden. Using a crop irrigation requirement of 18.10 in/yr (or 1.51 ft/yr) for pasture/turf near Cle Elum from the Washington Irrigation Guide and an application efficiency of 80%, the total outdoor irrigation water use is 0.022 ac-ft/yr. Consistent with WAC 173-539A-050(3), 90% of outdoor use is consumptively used, so: <b>Outdoor consumptive use = 0.019 ac-ft/yr</b></p> <p><b>Total consumptive use = 0.137 ac-ft/yr</b></p> <p><b>Contract water = 0.000 ac-ft/yr</b></p>

NARRATIVE DESCRIPTION OF PROJECT:

The subject parcel is located to the east of the Yakima River, on the west shore of Cabin Lake located in the NW¼NE¼, Section 2, T. 19 N., R. 16 E.W.M. The subject parcel is within the “green” area as noted in Trust Water Right CS4-02255(A)CTCL@2 (Swift Water Ranch LLC water bank).

The requestor proposes to offset the 0.137 ac-ft/yr of consumptive use for the project (1 residential connection and 500 ft<sup>2</sup> of lawn and garden) with 0.137 ac-ft/yr of mitigation water acquired from Trust Water Right No CS4-02255(A)CTCL@2.

Review of the local area hydrogeology suggests that the proposed well would likely capture water that would otherwise discharge to cabin lake, and ultimately the Yakima River. Impacts will likely occur below the confluence of the Yakima River and the Teanaway River.
