Mitigation Trust

2.0 & 3.0 liter settlements: \$3 Billion Nationwide
Court appointed Wilmington Trust as Trustee on 3/15/17

States, Puerto Rico, D.C., Tribes

Submit beneficiary applications summer/fall 2017.

Department of Ecology

Eligible for \$112.7 Million

Amount based on the number of affected vehicles registered.

Submit mitigation fund administration plan to Trustee approximately Fall 2017.

Tribes

Amounts will vary

Tribe amounts will vary based on a consultation with the Trustee.

Eligible Projects

May begin requesting funds 6 months after trust is established.

May replace or repower with new diesel engines, alternate fueled engines (compressed natural gas, propane, or hybrid), or all-electric engines.

Class 8 freight trucks & port drayage trucks

Class 4-7 local trucks

Ferries/tugboats

Shorepower for ocean going vessels

Freight switcher locomotives

Airport ground support equipment

Forklifts & cargo handling equipment at ports

Class 4-8 school/shuttle/transit buses.

Light duty ZEV supply equipment. 15% of funds.

Matching funds for eligible projects under DERA.

ZEV Investment

\$2 Billion over 10 years

- \$800 million in California
- \$1.2 billion in the rest of the nation

Project ideas may be submitted to electrifyamerica.com. Washington and Oregon jointly submitted ideas to VW for projects in our states.

Examples include:

- Electric vehicle charging stations at multi-unit dwellings, workplaces, and public sites.
- Electric vehicle fast charging stations available to vehicles using non-proprietary connectors.
- Brand-neutral outreach to increase awareness of ZEVs.

Consumer Relief

Options vary

2.0 Liter Diesel Engines

VW may recall, repair, buy back, or terminate leases on:

- 2009-2015 Jetta
- 2009-2014 Jetta Sportwagen
- 2013-2015 Beetle
- 2013-2015 Beetle Convertible
- 2010-2015 Audi A3
- 2010-2015 Golf
- 2015 Golf Sportwagen
- 2012-2015 Passat

Claims must be submitted by Sept. 2, 2018.

3.0 Liter Diesel Engines

VW may recall and repair:

- 2013 – 2015 Audi Q7
- 2014 – 2016 Audi A6, A7, A8, Q5
- 2013 – 2016 Porsche Cayenne
- 2013 – 2016 VW Touareg

If repairs are impossible, VW may buy back or terminate leases on:

- 2009 - 2012 Volkswagen Touareg
- 2009 - 2012 Audi Q7 diesels

Claim deadline has not been determined.
