This AIR OPERATING PERMIT is issued under the authority and provisions of the Federal Clean Air Act, (42 U.S.C. 7401, et. seq.) and the Washington Clean Air Act, Chapter 70.94, Revised Code of Washington and the Operating Permit Regulation, Chapter 173-401 Washington Administrative Code.

The U.S. Department of Energy (DOE), the permittee, at the Hanford Site is required to comply with provisions within this air operating permit, including all standard terms and general conditions and provisions contained in all the Attachments, identified below.

Attachments 1, 2, and 3 are integral and enforceable provisions of this permit.

Attachment 1 contains the State of Washington Department of Ecology (Ecology) permit terms and conditions.

Attachment 2 contains the State of Washington Department of Health (Health) Radioactive Air Emissions License (FF-01) as permit terms and conditions.

Attachment 3 contains the Benton Clean Air Agency (BCAA) permit terms and conditions applicable to the regulations of open burning and asbestos.

The regulatory agency relationships are described in the Statement of Basis (Statement). The Statement is issued by the permitting agencies as a separate supporting reference document to this air operating permit. The Statement contains non-enforceable legal and factual basis for permit conditions. The Statement also includes references to the applicable statutory or regulatory provisions, technical supporting information on specific emission units, and clarifications of specific requirements. [WAC 173-401-700(8)]

The Hanford Site and facilities are managed by two DOE Office of Environmental Management offices in Richland, Washington. The Office of River Protection (DOE-ORP) oversees the Hanford Site’s tank waste remediation system at the 200 Area. The Richland Operation Office (DOE-RL) is responsible for the Hanford Site’s environmental cleanup activities and the site-wide infrastructure support. The Pacific Northwest Site Office (DOE-PNSO) of the DOE Office of Science offices, located in Richland, provide programmatic oversight of some Hanford Site facilities utilized by the Pacific Northwest National Laboratory (PNNL). These PNNL-operated facilities are in the Hanford 300 area. DOE-RL is the owner and steward of these facilities. This joint DOE-RL/DOE-PNSO oversight is conducted in accordance with an Operational Agreement between DOE-RL and DOE-PNSO. The official permittee addresses are listed below:

2 The Hanford Air Operating Permit (AOP), hereinafter referred to as ‘permit’, was initially issued  
3 in 2001, and shall be renewed toward the end of each five-year term. The permit renewal of  
4 2013 is issued for a fixed term of 5 years from April 1, 2013 to March 31, 2018. Before the  
5 expiration date of March 31, 2018, the permittee shall apply for another five-year renewal  
6 according to WAC 173-401-500 and WAC 173-401-710 requirements. Ecology will notify the  
7 permittee at least 18 months in advance of the expiration date by sending an application for  
8 renewal which details the necessary data required to have a complete application submitted at  
9 least 6 months prior to the expiration date.

## 1    **2.0                    GENERAL HANFORD SITE INFORMATION**

2    The Hanford Site was acquired by the federal government in 1943 and for many years was  
3    dedicated primarily to the production of plutonium for national defense and the management of  
4    the resulting waste. With the shutdown of the production facilities in the 1970s and 1980s,  
5    missions were redirected to decommission and site cleanup, and diversified to include research  
6    and development in the areas of energy, waste management, and environmental restoration.  
7    Decommissioned facilities or emission units are those that cannot be operated as is, and are not  
8    planned to operate again. In the extremely unlikely event that a decommissioned facility or  
9    emission unit is reactivated, an applicable requirements assessment must be completed first.

10   The Hanford Site, located in south central Washington State, occupies about 1,450 square  
11   kilometers (approximately 560 square miles) of semi-arid shrub and grasslands just north of the  
12   confluence of the Snake and Yakima Rivers with the Columbia River. This land, with restricted  
13   public access, provides a buffer for the smaller areas historically used for the production of  
14   nuclear materials, waste storage, and waste disposal. The Hanford site is divided into the  
15   following five operational areas:

- 16       • 100 Area, including 100-B/C, 100-D, 100-DR, 100-F, 100-H, 100-K, and 100-N Areas,  
17       which lie along the south shore of the Columbia River in the northern portion.
- 18       • 200 Area, including 200 East and 200 West Areas, which lie in the center near the basalt  
19       outcrops of Gable Mountain and Gable Butte.
- 20       • 300 Area, near the southern border of the Hanford Site.
- 21       • 400 Area, between the 300 and 200 Areas.
- 22       • 600 Area, land not within the defined boundaries of the other operational areas.

23   Other areas and facilities that support Hanford Site activities can be found in the nearest cities  
24   (i.e., Richland, Kennewick, and Pasco). The facilities in these areas are not considered part of  
25   the Hanford Site major source because these areas are not considered contiguous or adjacent to  
26   the Hanford Site. These areas include, but are not limited to, the following facilities:

- 27       • 700 Area in Richland, i.e., 825 and 712 Buildings.
- 28       • Richland Central (RCHC) Area, i.e., Butler Loop facilities and the Hanford Technical  
29       Training Center.
- 30       • 1100 Area, Stevens Center, Evergreen Facilities, Cold Test Facility, various PNNL-  
31       operated facilities (as specified herein), Benton County Sheriff's Facilities including  
32       firing range and training

33   The Hanford site is considered a "major source" of air pollutant emitting activities. A partial list  
34   of North American Industry Classification System (NAICS) categories include:

1 This permit specifically excludes facilities that do not meet the criteria for inclusion in a major  
2 source subject to the Air Operating Permit Regulation (i.e., WAC 173-401-200(19)); the  
3 exclusion criteria are described in the Statement of Basis. Examples of facilities excluded at the  
4 time of permit renewal in 2013 are the following:

### 23 **3.0 EMISSION UNITS IDENTIFICATION**

24 Emission units subject to this permit are identified in Attachments 1 through 3.

### 26 **4.0 PERMIT PROVISOS**

#### 27 **4.1 Permit Shield**

28 **4.1.1** Compliance with the conditions of this permit shall be deemed compliance with  
29 those applicable requirements that are specifically included in and identified in  
30 the permit as of the date of permit issuance. [WAC 173-401-640(1)]

31 **4.1.2** The permit shield shall not apply to any insignificant emissions unit or activity  
32 designated under WAC 173-401-530. [WAC 173-401-530(3)]

#### 33 **4.2 Severability**

34 If any provision of this permit is held to be invalid, all unaffected provisions of the permit shall  
35 remain in effect and be enforceable. [WAC 173-401-620(2)(h); RCW 70.94.905 (State Only)]

1     **4.3           Property Rights**

2     This permit does not convey any property rights of any sort, or any exclusive privilege. [WAC  
3     173-401-620(2)(d)]

4     **4.4           Transfer of Ownership or Operation**

5     A change of ownership or operational control of this source shall be treated as an administrative  
6     permit amendment if no other changes in this permit are necessary and provided that a written  
7     agreement containing a specific date for transfer of permit responsibility, coverage, and liability  
8     between the current and new permittee has been submitted to Ecology, Health, and BCAA. DOE  
9     is considered the owner and operator of Hanford and contract changes to contractors to DOE are  
10    not considered changes in ownership or operational control. [WAC 173-401-720(1)(d)]

11    **4.5           Emissions Trading**

12    No permit revision shall be required under any approved economic incentives, marketable  
13    permits, emissions trading, and other similar programs or processes for changes that are provided  
14    in this permit. [WAC 173-401-620(2)(g)]

15    **4.6           Enforceability**

16    All terms and conditions are enforceable by the U.S. Environmental Protection Agency (EPA)  
17    and United States citizens unless specifically designated as not federally enforceable or listed as  
18    an inapplicable requirement in Table 5.1 [WAC 173-401-625]. Any paraphrasing of regulations  
19    or other applicable requirements is for the convenience of the reader. The underlying applicable  
20    requirement is the enforceable requirement.

21    **4.7           General Obligation – Exclusions**

22    Nothing in this permit shall alter or affect the following

- 23       a. The provisions of Section 303 of the FCAA (emergency orders), including the authority  
24       of the administrator under that section;
- 25       b. The liability of an owner or operator of a source for any violation of applicable  
26       requirements prior to or at the time of permit issuance;
- 27       c. The applicable requirements of the acid rain program, consistent with Section 408(a) of  
28       the FCAA;
- 29       d. The ability of EPA to obtain information from a source pursuant to Section 114 of the  
30       FCAA; or
- 31       e. The ability of Ecology to establish or revise requirements for the use of RACT as  
32       provided in Chapter 252, Laws of 1993.

33    [WAC 173-401-640(4)]

34    **4.8           Reasonably Available Control Technology**

35    Emission standards and other requirements contained in rules or regulatory orders in effect at the  
36    time of operating permit issuance or renewal shall be considered RACT for purpose of permit  
37    issuance or renewal. This does not preclude RACT determinations under Section 8, Chapter 252,  
38    Laws of 1993, which shall be incorporated into an operating permit as provided in WAC 173-  
39    401-730. [WAC 173-401-605(3) and RCW 70.94.154, 2011 (State Only)]

1 **4.9 Need to Halt or Reduce Activity Not a Defense**

2 It shall not be a defense for a permittee in an enforcement action that it would have been  
3 necessary to halt or reduce the permitted activity in order to maintain compliance with the  
4 conditions of this permit. [WAC 173-401-620(2)(b)]

5 **4.10 Permit Actions**

6 This permit may be modified, revoked, reopened, reissued, or terminated for cause. The filing of  
7 a request by the permittee for a permit modification, revocation and reissuance, termination, or  
8 of a notification of planned changes or anticipated noncompliance does not stay any permit  
9 condition. [WAC173-401-620(2)(c)]

10 **4.11 Permit Continuance**

11 This permit and all terms and conditions contained therein, including any permit shield provided  
12 under WAC 173-401-640, shall not expire until renewal permit has been issued or denied if a  
13 timely and complete application has been submitted. An application shield granted pursuant to  
14 WAC 173-401-705(2) shall remain in effect until the renewal permit has been issued or denied if  
15 a timely and complete application has been submitted. [WAC 173-401-620(2)(j)]

16 **4.12 Permit Appeals**

17 The permittee has the right to appeal this permit or any condition in the permit, including the  
18 attachments or any conditions in the attachments to the Pollution Control Hearings Board  
19 (PCHB) within 30 days of the date of receipt of this permit. The appeal process is governed by  
20 Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW  
21 43.21B.001(2).

22 To appeal, the permittee must do the following within 30 days of the date of receipt of this  
23 permit:

- 24 • File the appeal and a copy of this Order with the PCHB (see addresses below). Filing
- 25 means actual receipt by the PCHB during regular business hours.
- 26 • Serve a copy of the appeal and this Order on Ecology - in paper form - by mail or in
- 27 person (See addresses below). E-mail is not accepted.

28 The permittee must also comply with other applicable requirements in Chapter 43.21B RCW and  
29 Chapter 371-08 WAC.

## 4 5 **5.0 PERMIT ADMINISTRATION**

### 6 **5.1 Duty to Comply**

7 The permittee must comply with all conditions of this WAC 173-401 permit. Any permit  
8 noncompliance constitutes a violation of Chapter 70.94 RCW and, for federally enforceable  
9 provisions, a violation of the FCAA. Such violations are grounds for enforcement action; for  
10 permit termination, revocation and reissuance, or modification; or for denial of a permit renewal  
11 application. [WAC 173-401-620(2)(a)]

### 12 **5.2 Inspection and Entry**

13 On presentation of appropriate credentials and equipped with appropriate personal protective  
14 equipment, the permittee shall allow Ecology, Health, BCAA, and US EPA to perform the  
15 following:

- 16 a. Enter upon the permittee's premises where a Chapter 401 source is located or emissions  
17 related activity is conducted, or where records must be kept under the conditions of this  
18 permit.
- 19 b. Have access to and copy, at reasonable times, any records that must be kept under the  
20 conditions of this permit.
- 21 c. Inspect, at reasonable times, any facilities, equipment (including monitoring and air  
22 pollution control equipment), practices, or operations regulated or required under this  
23 permit. Health may require a demonstration of as low as reasonably achievable control  
24 technology (ALARACT) at any time. Where controlled access areas will be entered,  
25 Ecology, Health, or BCAA shall provide a reasonable advance notice and enter in the  
26 presence of a facility representative.
- 27 d. As authorized by WAC 173-400-105 and the FCAA, sample or monitor, at reasonable  
28 times, substances or parameters for the purpose of assuring compliance with the permit.

29 [WAC 173-401-630(2); RCW 70.94.200 (State only)]

30 **5.2.1** Ecology may require the permittee to conduct stack and/or ambient air monitoring  
31 and report the results to Ecology. [WAC 173-400-105(2)]

32 **5.2.2** Ecology may conduct or require that a test be conducted using approved EPA  
33 methods from 40 CFR Parts 51, 60, 61 and 63 or approved procedures contained  
34 in "Source Test Manual - Procedures for Compliance Testing," Ecology, 7/12/90.  
35 The permittee may be required to provide platform and sampling ports. Ecology  
36 shall be allowed to obtain a sample from any emissions unit. The permittee shall  
37 be given the opportunity to observe the sampling and to obtain a sample at the  
38 same time. [WAC 173-400-105(4)]

39 **5.2.3** The permittee shall respond in writing in a timely manner, or within a time limit  
40 set by Health per WAC 246-247-080(11) (State only), to inspection results that

1 require a facility to implement corrective actions or any other actions so directed  
2 by Health.

3 **5.2.4** Nothing in this condition shall limit the ability of EPA to inspect or enter the  
4 premises of the permittee under Section 114 or other provisions of the FCAA.

5 **5.2.5** No person shall obstruct, hamper, or interfere with any such authorized  
6 representative while in the process of carrying out their official duties. In the  
7 event the hazards associated with accessibility to a unit require training and/or  
8 restrictions or requirements for entry, the permittee shall inform Ecology, Health,  
9 or BCAA before arrival of those restrictions or requirements. The permittee shall  
10 be responsible for providing the necessary training, escorts, and support services  
11 to allow Ecology, Health, or BCAA to inspect. [WAC 173-401-630(2); WAC  
12 246-247-080(1); WAC 246-247-080(9); and RCW 70.94.200]

### 13 **5.3 Permit Fees**

14 The permittee shall pay fees as a condition of this permit in accordance with Ecology's fee  
15 schedule. Failure to pay fees in a timely fashion shall subject the permittee to civil and criminal  
16 penalties as described in Chapter 70.94 RCW. Ecology may revoke this permit if the permit fees  
17 are not paid [WAC 173-401-620(2)(f); RCW 70.94.162(1); and WAC 173-401-930(3)]

18 Per WAC 246-247-065 [Fees], fees for all non-AOP airborne emissions of radioactive materials  
19 shall be submitted in accordance with WAC 246-254-160. The permittee shall pay costs  
20 associated with direct staff time of the air emissions program in accordance with WAC 246-254-  
21 120 (1)(e). In any case where the permittee fails to pay a prescribed fee or actual costs incurred  
22 during a calendar quarter, Health (1) shall not process an application and (2) may suspend or  
23 revoke any license or approval involved; or (3) may issue any order with respect to licensed  
24 activities as Health determines appropriate or necessary to carry out the provisions of WAC 246-  
25 254-170. [WAC 246-247-065 (State only); WAC 246-254-120 (1)(e) (State only); and WAC

### 27 **5.4 Duty to Provide Information**

28 The permittee shall furnish to Ecology, Health, or BCAA, within a reasonable time, any  
29 information that Ecology, Health, or BCAA may request in writing to determine whether cause  
30 exists for modifying, revoking and reissuing, or terminating the permit or to determine  
31 compliance with the permit. On request, the permittee also shall furnish to Ecology, Health, or  
32 BCAA copies of records required to be kept by the permit or, for information claimed to be  
33 confidential, the permittee may furnish such records directly to the administrator along with a  
34 claim of confidentiality. Ecology, Health, or BCAA shall maintain confidentiality of such  
35 information in accordance with RCW 70.94.205. [WAC 173-401-620(2)(e)]

36 [Note: The permittee shall afford access to requested copies of records containing classified  
37 information provided the Ecology, Health or BCAA representatives reviewing the documents  
38 possess (1) the appropriate access authorizations (security clearances) for the level and category  
39 of information involved, (2) all required formal access approval(s), and (3) a legitimate need-to-  
40 know. WAC 246-247-080(10) (State only)]

1 **5.5 Submittals**

37 **5.5.5** Any application form, report, or compliance certification submitted to Ecology,

39 responsible official of truth, accuracy, and completeness. All certifications shall  
40 state that based on information and belief formed after reasonable inquiry, the

1 statements and information in the document are true, accurate, and complete.

3 **5.5.6** No person shall make any false material statement, representation or certification  
4 in any form, notice or report required under chapter 70.94 or 70.120 RCW, or any  
5 ordinance, resolution, regulation, permit or order in force pursuant thereto.  
6 [WAC 173-400-105(7)]

7 **5.5.7** No person shall render inaccurate any monitoring device or method required  
8 under chapter 70.94 or 70.120 RCW, or any ordinance, resolution, regulation,  
9 permit, or order in force pursuant thereto. [WAC 173-400-105(8)]

10 **5.6 Semiannual Reporting**

11 **5.6.1** Semiannual reports shall be submitted by September 15<sup>th</sup> and by March 15<sup>th</sup>.  
12 Reports for January 1 through June 30 and July 1 through December 31, shall be  
13 due September 15<sup>th</sup> and March 15<sup>th</sup>, respectively. All instances of deviations from  
14 permit requirements must be clearly identified in such reports. All required  
15 reports must be certified by a responsible official consistent with WAC 173-401-  
16 520. [WAC 173-401-615(3)(a)]

17 **5.6.2** Each semiannual report shall contain the following information for the applicable  
18 reporting period.

- 19 a. Reference to reports submitted to the regulatory agencies as required by  
20 section 5.16.
- 21 b. Reports of any required monitoring not previously submitted or reference  
22 to reports of required monitoring that were submitted previously during  
23 the reporting period.
- 24 c. A summary of any substantiated air emission complaint investigation(s)  
25 required in Table 1.2 of Attachment 1 and issued during the reporting  
26 period.
- 27 d. For all minor radioactive emission units (potential to emit <0.1 mrem to  
28 the maximally exposed individual (MEI) listed in Attachment 2), a general  
29 statement confirming that any required monitoring was conducted to  
30 verify low emissions during the reporting period for those emission units  
31 with specific periodic monitoring required during that period. For all  
32 emission units with continuous monitoring, a general statement will be  
33 provided stating that required monitoring operated continuously.
- 34 e. Emission unit(s) that operated for any part of the calendar year, and were  
35 not closed per WAC 246-247-080(6) (reference to FF-01 Attachment 2),  
36 will have monitoring data reported in the annual NESHAP report (Section  
37 5.11). Diffuse and Fugitive minor emission units listed in Attachment 2  
38 are not required to be reported on except annually as a composite portion  
39 of the annual NESHAP report.
- 40 f. List any new regulatory orders, (e.g., Notice of Construction) imposed  
41 during the reporting period by Ecology or Health.

42 [WAC 173-401-615(3)(a)]

- 1 **5.6.3** Submittal of the information required in Section 5.11 Annual NESHAPs Report  
2 will meet the semiannual reporting requirements of diffuse and fugitive sources in  
3 Table 2.1 and point source emission unit specific information (i.e.; height,  
4 diameter, velocity, temperature, and operational status) of the FF-01 License.
- 5 **5.7 Recordkeeping**
- 6 **5.7.1** Permittee shall keep records of required monitoring information that includes,  
7 where applicable, the following:
- 8 a. The date, place, and time of sampling or measurements;  
9 b. The date(s) analyses were performed;  
10 c. The company or entity that performed the analyses;  
11 d. The analytical techniques or methods used;  
12 e. The results of such analyses; and  
13 f. The operating conditions as existing at the time of sampling or  
14 measurement  
15 [WAC 173-401-615(2)(a)]
- 16 **5.7.2** Permittee shall keep records describing changes made at the source that result in  
17 emissions of a regulated air pollutant subject to an applicable requirement, but not  
18 otherwise regulated under the permit, and the emissions resulting from those  
19 changes. [WAC 173-401-615(2)(b)]
- 20 **5.7.3** Permittee shall retain records of all required monitoring data and support  
21 information for a period of at least five (5) years from the date of the monitoring  
22 sample, measurement, report, or application. Support information includes all  
23 calibration and maintenance records and all original strip-chart recordings from  
24 continuous monitoring instrumentation, and copies of all reports required by this  
25 permit.  
26 [WAC 173-401-615(2)(c)]
- 27 **5.8 Monitoring and Recordkeeping for Emission Units without**  
28 **Continuous Operation**
- 29 **5.8.1** Emission Units with Nonradioactive Air Emissions Conditions
- 30 The permittee is not required to conduct the monitoring and associated  
31 recordkeeping for any emission unit if the emission unit did not operate at any  
32 time between required monitoring events (e.g., if the monitoring requires  
33 recording pressure drop daily, such readings would not be required on any full  
34 day in which the emission unit did not operate), provided the following conditions  
35 are met.
- 36 **5.8.1.1** Permanent shutdown of the emission unit:
- 37 a. The permittee makes a contemporaneous record in a log or file maintained  
38 on site of the date and time that the emission unit ceased operation.

1           b.       The permittee shall provide written notice to Ecology within a reasonable  
2           time.

3   **5.8.1.2**   Temporary shutdown of the emission unit:

4           a.       The permittee makes a contemporaneous record in a log or file maintained  
5           on site of the date and time that the emission unit ceased operation and the  
6           reason why the emission unit did not operate.

7           b.       The permittee makes a contemporaneous record in a log or file maintained  
8           on site of the date and time that the emission unit resumed operation.

9           c.       The periodic report of monitoring required by Section 5.6 and/or the  
10          specific permit condition includes a summary of the period or periods  
11          when the emission unit did not operate.

12   **5.8.2**       Emission Units with Radioactive Air Emission Conditions

13           The permittee is not required to conduct the monitoring and associated  
14           recordkeeping for any emission unit if the emission unit did not operate at any  
15           time between required monitoring events (e.g., if the monitoring requires  
16           continuous sampling, such readings would not be required on any full day in  
17           which the emission unit did not operate), provided the following conditions are  
18           met.

19           Note: These conditions do not apply to temporary radioactive emissions units  
20           [e.g., high-efficiency particulate air (HEPA) vacuums or portable/temporary  
21           radioactive air emission units (PTRAEUs), etc].

22   **5.8.2.1**    Permanent shut down of an emission unit

23   **5.8.2.1.1**   The permittee shall complete the monitoring and associated recordkeeping for the  
24   period before the shutdown.

25   **5.8.2.1.2**   The facility shall file a report of closure with Health whenever operations  
26   producing emissions of radioactive material permanently are ceased at any  
27   emission unit (except temporary emission units) regulated under WAC 246-247.  
28   The closure report shall indicate whether, despite cessation of operations, there is  
29   still a potential for radioactive air emissions and a need for an active or passive  
30   ventilation system with emission control and/or monitoring devices. If  
31   decommissioning is planned and will constitute a modification, a NOC shall be  
32   required, as applicable, in accordance with WAC 246-247-080(6).

33   **5.9**        **Annual Air Emission Inventory**

34   The permittee shall upon notification by the director of Ecology, maintain records on the type  
35   and quantity of emissions from the source and other information deemed necessary to determine  
36   whether the source is in compliance with applicable emission limitations and control measures.  
37   The annual emission inventory shall be submitted to Ecology on forms provided by Ecology.  
38   When submittal of emission inventory information for criteria pollutants is requested by  
39   Ecology, the emissions inventory shall be submitted no later than 105 days after the end of the  
40   calendar year. The annual air emissions inventory report will minimally contain information on  
41   air emissions:

- 1 a. for emission unit composites, as requested and listed in the permit Attachment 1,  
2 *Tables 1.3, 1.4, 1.5, and,*  
3 b. for other emission units as directed by Ecology on forms provided to the permittee.  
4 [WAC 173-400-105]

## 5 **5.10 Annual Compliance Certification**

6 **5.10.1** Annual compliance certification will be certified consistent with WAC 173-401-  
7 520 requirements, and submitted by July 31 for the previous calendar year. The  
8 report is to be certified for truth, accuracy, and completeness by a Responsible  
9 Official [WAC 173-401-200(29)]. The compliance certification will consist of  
10 the following:

- 11 a. Each emission unit-specific term or condition listed in Attachments 1, 2,  
12 and 3, pursuant to the source's or emission unit's operational portion of the  
13 calendar year. Source(s) or emission unit(s) closed per request letter  
14 (Ecology) or pursuant to WAC 246-247-080(6) (DOH), prior to January 1  
15 of the reporting period will not be included in the calendar year  
16 certification report.  
17 b. The compliance status  
18 c. Whether compliance was continuous, intermittent, or not applicable  
19 d. The method(s) used to determine the compliance status of the source over  
20 the reporting period consistent with WAC 173-401-615(3)(a)  
21 e. Such other facts as Ecology, Health, or BCAA may require in order to  
22 determine the compliance status of the source

23 **5.10.2** All compliance certifications shall be submitted to Ecology, Health, or BCAA  
24 with a copy to EPA at the address shown in Section 5.5 by July 31 of the  
25 following calendar year.

26 **5.10.3** Submittal of the information required in Section 5.11 Annual NESHAPs Report  
27 will meet the annual compliance certification requirements of diffuse and fugitive  
28 sources in Table 2.1 of Attachment 1 and point source emission unit specific  
29 information (i.e.; height, diameter, velocity, temperature, and operational status)  
30 of the FF-01 License.

31 [WAC 173-401-520, WAC 173-401-630 and WAC 246-247]

## 32 **5.11 Annual NESHAPs Reporting**

33 Submit an annual NESHAPs report that shall consist of the annual Radionuclide Air Emissions  
34 Report for the Hanford Site required by 40 CFR 61.94

35 **5.11.1** Compliance with this standard shall be determined by calculating the highest  
36 effective dose equivalent to any member of the public at any offsite point where  
37 there is a residence, school, business or office. The owners or operators of each  
38 facility shall submit an annual report to both EPA headquarters and the  
39 appropriate regional office by June 30 which includes the results of the  
40 monitoring as recorded in DOE's Effluent Information System and the dose  
41 calculations required by 40 CFR 61.93(a) for the previous calendar year.

- 1 **5.11.2** The annual report shall include:
- 2 a. Name and location of the facility
- 3 b. List of the radioactive materials used at the facility
- 4 c. Descriptions of the handling and processing that the radioactive materials
- 5 undergo at the facility
- 6 d. List of the stacks or vents or other points where radioactive materials are
- 7 released to the atmosphere.
- 8 e. Description of the effluent controls used on each stack, vent, or other
- 9 release point and an estimate of the efficiency of each device.
- 10 f. Distances from the point(s) of release to the nearest residence, school,
- 11 business or office and the nearest farms producing vegetables, milk, and
- 12 meat.
- 13 g. Values for all other user supplied input parameters for computer models
- 14 (e.g., meteorological data) and sources of these data.
- 15 h. Brief description of all construction and modifications completed in the
- 16 calendar year for which the report is prepared, but for which the
- 17 requirement to apply for approval to construct or modify was waived
- 18 under 40 CFR 61.96 and associated documentation developed by DOE to
- 19 support the waiver. EPA reserves the right to require that DOE send to
- 20 EPA all the information that normally would be required in an application
- 21 to construct or modify, following receipt of the description and supporting
- 22 documentation.
- 23 **5.11.3** The annual report shall also include:
- 24 a. Results of emission measurements for those emission units subject only to
- 25 periodic confirmatory measurements
- 26 b. Wind rose or joint frequency table
- 27 c. Annual average ambient temperature
- 28 d. Annual average emission unit gas temperature, if available
- 29 e. Annual total rainfall
- 30 f. Annual average emission unit flow rate and total volume of air released
- 31 during the calendar year
- 32 g. If additional information is available in another annual report, the
- 33 permittee may provide a copy of that report along with the listed
- 34 information requirements. [WAC 246-247-080(3)(State only)]
- 35 **5.11.4** Each report shall be signed and dated by a corporate officer or public official in
- 36 charge of the facility and contain the following declaration immediately above the
- 37 signature line: "I certify under penalty of law that I have personally examined
- 38 and am familiar with the information submitted herein and based on my inquiry of
- 39 those individuals immediately responsible for obtaining the information, I believe
- 40 that the submitted information is true, accurate and complete. I am aware that
- 41 there are significant penalties for submitting false information including the

1 possibility of fine and imprisonment. {18 U.S.C. 1001}.” Note: The certification  
2 language (including the 18 U.S.C. 1001) comes directly from 40 CFR 61.94(b)(9)  
3 and is an applicable requirement for the annual report. The report is to be  
4 submitted to both the Environmental Protection Agency as well as the Department  
5 of Health.

## 6 **5.12 Environmental Surveillance Program**

7 Under the requirements of WAC 246-247-075(9), Health may conduct an environmental  
8 surveillance program to ensure that radiation doses to the public from emission units are in  
9 compliance with applicable standards. Health may require the operator of an emission unit to  
10 conduct stack sampling, ambient air monitoring, or other testing as necessary to demonstrate  
11 compliance with the standards in 40 C.F.R. 61.92 and WAC 246-247-040.

## 12 **5.13 Emission Standards and Controls for Sources Emitting Gasoline** 13 **Vapors**

14 Stage 1 requirements are applicable to 20 eastern Washington counties (including Benton  
15 County) with new gasoline dispensing facilities greater than 10,000 gallons storage capacity  
16 (Table 1.7 in Attachment 1). Total annual throughput records shall be maintained for the most  
17 recent 2- year period. [WAC 173-491]

## 18 **5.14 Accidental Release Prevention Requirements**

19 The Hanford Site is currently not subject to 40 CFR 68 (Chemical Accident Prevention  
20 Provisions).

## 21 **5.15 Approval Order Terms and Conditions that Become Irrelevant During** 22 **Permit Term**

23 Nothing herein shall be construed to preclude the permittee from making changes consistent with  
24 Chapter 401 that would render existing permit compliance terms and conditions irrelevant.

25 [(WAC 173-401-725(4)(a))]

## 26 **5.16 Permit Deviation Reporting**

27 The permittee shall report deviations from permit conditions, including those attributable to  
28 upset conditions as defined below, the probable cause of such deviations, and any corrective  
29 actions or preventative measures taken.

### 30 **5.16.1 Potential Threats to Human Health or Safety**

31 Deviations, which represent a potential threat to human health or safety, shall be  
32 reported promptly or as soon as possible. Promptly, as defined here, means as  
33 soon as possible following discovery<sup>1</sup>, but in no case later than 12 hours after  
34 discovery<sup>1</sup> of a potential threat to human health or safety. This notice shall  
35 contain a description of the emergency, any steps taken to mitigate emissions, and  
36 corrective actions taken. This notice fulfills the immediate reporting requirements

---

<sup>1</sup> Qualitative determination that a potential threat to public health or safety exists or existed after an evaluation of pertinent information.

1 of WAC 173-401-615(3)(b), WAC 173-400-107(3) and WAC 246-247-  
2 080(5)(State Only).

### 3 **5.16.2 Non-Health or Safety Related Deviations**

4 **5.16.2.1** Other deviations from permit requirements or excess emissions shall be reported  
5 within 30 days after the end of the month during which the deviation is discovered  
6 or as part of routine emission monitoring reports. [WAC 173-401-615(3)(b) and  
7 WAC 173-400-107(3)]

8 **5.16.2.2** Additional written reports may be required by either Ecology or Health, according  
9 to the requirements of WAC 173-400-107(3) or WAC 246-247-080(5)(State only)  
10 respectively.

11 **5.16.2.3** Notification must be given to Health within 24 hours (or during the course of the  
12 next normal business day) from the time of discovery of the condition or emission  
13 that would require notification pursuant to WAC 246-247-080(5)(State only).  
14 Such notification shall be required for other than normal operations when a  
15 potential or actual release of radionuclides to the air is due to any one or more of  
16 the following:

- 17 a. Non-routine bypass or failure of required abatement control technology  
18 identified in Attachment 2
- 19 b. Non-routine and/or unexpected operational changes resulting in increased  
20 emissions
- 21 c. An excess of the dose standard of 10 mrem/yr for the Hanford Site
- 22 d. Emission in excess of emission limits or conditions in a regulatory order  
23 (e.g., NOC, enforcement actions, or License)

### 24 **5.16.3 Excess Emissions Due to Emergency**

25 The permittee may seek to establish that noncompliance with a technology-based<sup>2</sup>  
26 emission limitation under this permit was due to an emergency<sup>3</sup>, in accordance  
27 with WAC 173-401-645. To do so, the permittee shall demonstrate the  
28 affirmative defense of emergency through properly signed, contemporaneous  
29 operating logs, or other relevant evidence that:

- 30 a. An emergency occurred and that the permittee can identify the cause(s) of  
31 the emergency;
- 32 b. The permitted source was at the time being properly operated;

<sup>2</sup> Technology-based emission limits are those established on the basis of emission reductions achievable with various control measures or process changes (e.g., a new source performance standard) rather than those established to attain a health based air quality standard.

<sup>3</sup> An “emergency” means any situation arising from sudden and reasonably unforeseeable events beyond the control of this source, including acts of God, which situation requires immediate corrective action to restore normal operation, and that causes this source to exceed a technology-based emission limitation under this permit, due to unavoidable increases in emissions attributable to the emergency. An emergency shall not include noncompliance to the extent caused by improperly designed equipment, lack of preventative maintenance, careless or improper operation, or operator error.

1 c. During the period of the emergency the permittee did not allow the  
2 condition to persist and took all reasonable steps to minimize levels of  
3 emissions that exceeded the emissions standards, or other requirements in  
4 this permit;

5 d. The permittee submitted notice of the emergency to Ecology (non-  
6 radiological emissions) and Health (radiological emissions) within 24  
7 hours of the time when emission limitations were exceeded due to the  
8 emergency or within 12 hours when there is a threat to human health.  
9 This notice must contain a description of the emergency, any steps taken  
10 to mitigate emissions, and corrective actions taken

11 [WAC 173-400-107, WAC 173-401-615, WAC 173-401-645, and WAC 246-  
12 247-080(State only)]

### 13 **5.16.4 Unavoidable Excess Emissions**

14 **5.16.4.1** Excess emissions determined to be unavoidable under the procedures and criteria  
15 in WAC 173-400-107 shall be excused and not subject to penalty.

16 **5.16.4.2** The permittee shall have the burden of proving to Ecology that excess emissions  
17 were unavoidable. .

18 **5.16.4.3** Excess emission due to startup or shutdown conditions shall be considered  
19 unavoidable provided the source reports as required under WAC 173-400-107(3)  
20 and adequately demonstrates that the excess emissions could not have been  
21 prevented through careful planning and design and if a bypass of control  
22 equipment occurs, that such bypass is necessary to prevent loss of life, personal  
23 injury, or severe property damage.

24 **5.16.4.4** Excess emission due to scheduled maintenance shall be considered unavoidable if  
25 the source reports as required under WAC 173-400-107(3) and adequately  
26 demonstrates that the excess emissions could not have been avoided through  
27 reasonable design, better scheduling for maintenance or through better operation  
28 and maintenance practices.

29 **5.16.4.5** Excess emissions due to upsets shall be considered unavoidable provided the  
30 source reports as required under WAC 173-400-107(3) and adequately  
31 demonstrates that:

32 a. The event was not caused by poor or inadequate design, operation,  
33 maintenance, or any other reasonably preventable condition;

34 b. The event was not of a recurring pattern indicative of inadequate design,  
35 operation, or maintenance; and

36 c. The operator took immediate and appropriate corrective action in a  
37 manner consistent with good air pollution control practice for minimizing  
38 emissions during the event, taking into account the total emissions impact  
39 of the corrective action, including slowing or shutting down the emission  
40 unit as necessary to minimize emissions, when the operator knew or

1                   should have known that an emission standard or permit condition was  
2                   being exceeded.

3 **5.16.4.6**       Excess emissions which represent a potential threat to human health or safety or  
4                   which the owner or operator of the source believes to be unavoidable shall be  
5                   reported to Ecology **as soon as possible**. Other excess emissions shall be  
6                   reported within **thirty (30) days** after the end of the month during which the event  
7                   occurred or as part of the routine emission monitoring reports. Upon request by  
8                   Ecology, the permittee shall submit a full written report including the known  
9                   causes, the corrective actions taken, and the preventative measures to be taken to  
10                  minimize or eliminate the chance of recurrence.

11                  [WAC 173-400-107(3)(State only)]

## 12 **5.17            Reporting of Greenhouse Gases**

13                  Beginning with 2012 emissions, if the permittee emits 10,000 metric tons of GHGs or more per  
14                  calendar year, as defined under WAC 173-441-020(1)(g), reporting of GHG to Ecology is  
15                  mandatory. (Note: WAC 173-441-030(5) details reporting requirements for facilities which  
16                  exceed the threshold in 2012 or later years, but subsequently have lower annual CO<sub>2</sub>e  
17                  emissions).

18                  The permittee is subject to the following program requirements if GHG emissions exceed 10,000  
19                  metric tons of GHGs.

20                  Permittee shall develop a written GHG monitoring plan in accordance with WAC 173-441-  
21                  050(6)(e). The permittee shall revise the GHG monitoring plan as needed to reflect changes in  
22                  processes, monitoring instrumentation, and quality assurance procedures; or to improve  
23                  procedures for the maintenance and repair of monitoring systems to reduce the frequency of  
24                  monitoring equipment downtime.

25                  [WAC 173-441-050(6)(State only)]

26                  Reports must meet the requirements of WAC 173-441-050, and include the annual emissions of  
27                  the GHGs listed in WAC 173-441-040 from source categories listed in WAC 173-441-120. The  
28                  annual GHG report shall be submitted electronically in accordance with the requirements of  
29                  WAC 173-441-050 and 173-441-060 and in a format specified by Ecology.

30                  All requests, notifications, and communications to Ecology pursuant to GHG emissions  
31                  reporting, other than submittal of the annual GHG report, shall be submitted to the following  
32                  address:

38                  The permittee shall submit a revised annual GHG report within forty-five days of discovering  
39                  that an annual GHG report that the permittee previously submitted contains one or more  
40                  substantive errors. A substantive error is an error that impacts the quantity of GHG emissions

1 reported or otherwise prevents the reported data from being validated or verified. The revised  
2 report must correct all substantive errors.

3 Ecology may notify the permittee in writing that an annual GHG report previously submitted  
4 contains one or more substantive errors. Such notification will identify each such error. The  
5 permittee shall, within forty-five days of receipt of the notification, either resubmit the report  
6 that, for each identified substantive error, corrects the identified substantive error (in accordance  
7 with the applicable requirements of this permit) or provide information demonstrating that the  
8 previously submitted report does not contain the identified substantive error or that the identified  
9 error is not a substantive error.

10 [WAC 173-441-050 (State only); WAC 173-441-100 (State only)]

11 **5.17.1** Facilities required to report GHG emissions to the EPA under 40 C.F.R. Part 98  
12 must submit a report to Ecology no later than **March 31<sup>st</sup>** of each calendar year  
13 for GHG emissions in the previous calendar year.

14 **5.17.2** Facilities which are not anticipated to be required to report GHG emissions to the  
15 EPA under 40 C.F.R. Part 98 must submit a report to Ecology, no later than  
16 **October 31<sup>st</sup>** of each calendar year, for GHG emissions in the previous calendar  
17 year if GHG emissions were equal to or greater than the 10,000 metric tons  
18 threshold. Permittee is expected to exceed this threshold and will be required to  
19 submit a GHG report by the October 31 deadline.

20 **5.17.3** The Permittee shall maintain records in accordance with WAC 173-441-050.

21 [WAC 173-441-050(6) (State only)]

22 Permittee must pay a reporting fee for each year they submit a report to Ecology.  
23 [WAC 173-441-110 (State only)]

## 24 **5.18 Permit Renewal and Expiration**

25 **5.18.1** This permit is issued for a fixed term of five (5) years. The permittee's right to  
26 operate this source terminates with the expiration of this permit unless a timely  
27 and complete renewal application is submitted at least 6 months, but no earlier  
28 than 18 months, before the date of permit expiration. On receipt of a timely and  
29 complete application for renewal, this source may continue to operate subject to  
30 final action by Ecology, Health, and BCAA on the renewal application. This  
31 protection shall cease to apply if, subsequent to a completeness determination, the  
32 applicant fails to submit by the deadline specified in writing by Ecology, Health,  
33 or BCAA any additional information identified as being needed to process the  
34 renewal application. The application for renewal shall include the current permit  
35 number, description of permit revisions and off-permit changes that occurred  
36 during the permit term, any applicable requirements that were promulgated and  
37 not incorporated into the permit during the permit term and shall provide a  
38 compliance schedule therefore, and information listed in the renewal application  
39 sent to the applicant.

1 **5.18.2** Upon receipt of a complete and timely application for renewal, this source may  
2 continue to operate subject to final action by Ecology on the renewal application.

24 **5.18.4** Duty to supplement or correct application. The permittee, upon becoming aware  
25 that any relevant facts were omitted or incorrect information was submitted in the  
26 permit application, shall promptly submit such supplementary facts or corrected  
27 information. The permittee shall also provide additional information as necessary  
28 to address any requirements that become applicable to the source after the date a  
29 complete renewal application was submitted but prior to release of a draft permit.  
30 [WAC 173-401-500(6).]

31 **5.19 Off-permit Changes**

32 **5.19.1** The source shall be allowed to make changes not specifically addressed or  
33 prohibited by the permit terms and conditions without requiring a permit revision,  
34 provided that the proposed changes do not weaken the enforceability of the  
35 existing permit conditions. Any change that is a Title I modification or is a  
36 change subject to the acid rain requirements under Title IV of the FCAA must be  
37 submitted as a permit revision.

38 **5.19.2** Each such change shall meet all applicable requirements and shall not violate any  
39 existing permit term or condition.

40 **5.19.3** Sources must provide contemporaneous written notice to Ecology and EPA of  
41 each such change.

Such written notice shall describe each such change, including the date, any change in emissions, pollutants emitted, and any applicable requirement that would apply as a result of the change.

**5.19.4** The change shall not qualify for the permit shield under WAC 173-401-640.

**5.19.5** The permittee shall keep a record describing changes made at the source that result in emissions of a regulated air pollutant subject to an applicable requirement, but not otherwise regulated under the permit, and the emissions resulting from those changes.

**5.19.6** A source making a change under this section shall comply with applicable preconstruction review requirements established pursuant to RCW 70.94.152. [WAC 173-401-724]

**5.20 Changes Not Requiring Permit Revisions**

**5.20.1** Permittee is authorized to make the changes described in this section without a permit revision, providing the following conditions are met:

- a. The proposed changes are not Title I modifications;
- b. The proposed changes do not result in emissions which exceed those allowable under the permit, whether expressed as a rate of emissions, or in total emissions;
- c. The proposed changes do not alter permit terms that are necessary to enforce limitations on emissions from units covered by the permit; and
- d. The source provides the administrator and Ecology with written notification at least seven (7) days prior to making the proposed changes except that written notification of a change made in response to an emergency shall be provided as soon as possible after the event.

The permittee and Ecology shall attach each notice to their copy of the relevant permit.

**5.20.2** Pursuant to conditions in 5.20.1, a Chapter 173-401 WAC source is authorized to make Title V Section 502(b)(10) changes without a permit revision.

**5.20.2.1** For each such change, the written notification required shall include a brief description of the change within the permitted source, the date on which the change will occur, any change in emissions, and any permit term or condition that is no longer applicable as a result of the change.

**5.20.2.2** The permit shield authorized under WAC 173-401-640 shall not apply to any change made pursuant to this paragraph.

**5.20.3** A Chapter 173-401 WAC source is authorized to trade increases and decreases in emissions in the permitted source, where the Washington state implementation plan (SIP) provides for such emissions trades without requiring a permit revision. This provision is available in those cases where the permit does not already provide for such emissions trading.

**5.20.3.1** Written notification shall include such information as may be required by the provision in the Washington SIP authorizing the emissions trade, including at a minimum, when the proposed change will occur, a description of each such change, any change in emissions, the permit requirements with which the source will comply using the emissions trading provisions of the Washington SIP, and the pollutants emitted subject to the emissions trade. The notice shall also refer to the provisions with which the source will comply in the applicable implementation plan and that provide for the emissions trade.

**5.20.3.2** The permit shield described in WAC 173-401-640 shall not extend to any change made under this paragraph. Compliance with the permit requirements that the source will meet using the emissions trade shall be determined according to requirements of the applicable SIP authorizing the emissions trade.

**5.20.4** Upon the request of the permittee, Ecology shall issue permits that contain terms and conditions, including all terms required under WAC 173-401-600 through 173-401-630 to determine compliance, allowing for the trading of emissions

1 increases and decreases in the WAC 173-401 source solely for the purpose of  
2 complying with a federally enforceable emissions cap that is established in the  
3 permit independent of otherwise applicable requirements. The permittee shall  
4 include in its application proposed replicable procedures and permit terms that  
5 ensure the emissions trades are quantifiable and enforceable. The emissions  
6 trading provisions shall not be applied to any emissions units for which emissions  
7 are not quantifiable or for which there are no replicable procedures to enforce the  
8 emissions trades.

9 **5.20.4.1** Written notification, shall state when the change will occur and shall describe the  
10 changes in emissions that will result and how these increases and decreases in  
11 emissions will comply with the terms and conditions of the permit.

12 **5.20.4.2** The permit shield described in WAC 173-401-640 shall extend to terms and  
13 conditions that allow such increases and decreases in emissions.

14 **5.20.5** A source making a change under this section shall comply with applicable  
15 preconstruction review requirements established pursuant to 70.94.152 RCW.

16 [WAC 173-401-722]

## 17 **5.21 Reopening for Cause**

18 **5.21.1** Permits shall be reopened and revised under any of the following circumstances:

- 19 a. Additional applicable requirements become applicable to a Chapter 173-  
20 401 WAC source with a remaining permit term of three (3) or more years.  
21 Such a reopening shall be completed no later than eighteen (18) months  
22 after promulgation of the applicable requirements. No such reopening is  
23 required if the effective date of the requirement is later than the date on  
24 which the permit is due to expire, unless the original permit or any of its  
25 terms and conditions have been extended pursuant to WAC 173-401-  
26 620(2)(j);
- 27 b. Ecology, Health, BCAA, or the administrator determines that the permit  
28 contains a material mistake or that inaccurate statements were made in  
29 establishing the emissions standards or other terms or conditions of the  
30 permit; or
- 31 c. Ecology, Health, BCAA, or the administrator determines that the permit  
32 must be revised or revoked to assure compliance with the applicable  
33 requirements.

34 **5.21.2** Proceedings to reopen and issue a permit shall follow the same procedures as  
35 apply to initial permit issuance and shall affect only those parts of the permit for  
36 which cause to reopen exists. Such reopening shall be made as expeditiously as  
37 practicable.

38 **5.21.3** All permit conditions remain in effect until such time as Ecology takes final  
39 action. Respective regulatory agencies may take temporary corrective measures  
40 in cases of material mistakes or potential negative impact to public health.

1 **5.21.4** Reopenings under this section shall not be initiated before a notice of such intent  
2 is provided to the Chapter 173-401 WAC source by Ecology at least thirty (30)  
3 days in advance of the date that the permit is to be reopened, except that Ecology,  
4 Health, or BCAA may provide a shorter time period in the case of an emergency.  
5 [WAC 173-401-730]

## 6 **5.22 New Source Review**

7 The permittee shall not construct new sources or make modifications required to be reviewed  
8 under WAC 173-400-110, WAC 173-400-560, WAC 173-400-720, WAC 173-400-820, or WAC

10 with those regulations and pays the appropriate fees required by WAC 173-455-120. [WAC

12 WAC 173-400-720 (State Only); WAC 173-400-820 (State only); WAC 173-455-120 (State  
13 only); WAC 173-460-040 (State only); RCW 70.94.152, 2011 (State only)]

## 14 **5.23 Replacement or Substantial Alteration of Emission Control** 15 **Technology**

16 Prior to replacing or substantially altering emission control technology subject to review under  
17 WAC 173-400-114, the permittee shall file for and obtain approval from Ecology according to  
18 that regulation. The permittee shall pay the appropriate fees required by WAC 173-455-100  
19 prior to commencing construction. [WAC 173-400-045(4), (State only); WAC 173-400-114,  
20 (State only); WAC 173-455-100 (State only), RCW 70.94.153, 2011 (State only)]

## 21 **5.24 Nonroad Engines**

22 Prior to installation or operation of a nonroad engine, as defined in WAC 173-400-030(56), the  
23 permittee shall meet the requirements of WAC 173-400-035, as applicable. If the nonroad  
24 engine(s) has a cumulative maximum rated brake horsepower greater than 500, a notification of  
25 intent to operate will be submitted to Ecology. If the nonroad engine(s) has a cumulative  
26 maximum rated brake horsepower greater than 2,000, the permittee will not operate the engine(s)  
27 unless Ecology issues written approval to operate. [WAC 173-400-035, (State only)]

## 28 **5.25 Reserved**

## 29 **5.26 Federal Chlorofluorocarbon Requirements**

30 **5.26.1** The permittee shall comply with the following standards for recycling and  
31 emissions reductions pursuant to 40 CFR 82, Subpart F, except as provided for  
32 MVACs in Subpart B:

- 33 a. Persons conducting maintenance, service, repair, or disposing must follow  
34 the prohibitions pursuant to 40 CFR 82.154.
- 35 b. Persons opening appliances for maintenance, service, repair or disposal  
36 must comply with the required practices pursuant to 40 CFR 82.156.
- 37 c. Equipment used during the maintenance, service, repair or disposal must  
38 comply with the standards for recycling and recovery equipment pursuant  
39 to 40 CFR 82.158.

- 1           d.       Persons performing maintenance, service, repair or disposal of appliances
- 2                    must be certified by an approved technician certification program pursuant
- 3                    to 40 CFR 82.161.
- 4           e.       Persons conducting maintenance, service, repair, or disposing must certify
- 5                    to the Administrator that such person has acquired certified recovery or
- 6                    recycling equipment pursuant to 40 CFR 82.162.
- 7           f.       Persons disposing of small appliances, MVACs, and MVAC-like

19 **5.26.2**       If the permittee manufactures, transforms, imports, or exports a class I or class II

22 **5.26.3**       If the permittee performs service, maintenance, repair or disposal of air  
 23 conditioners in MVACs and MVAC-like appliances (as that term is defined in 40  
 24 CFR 82.152) that involves refrigerant as defined in 40 CFR 82.32(f), the  
 25 permittee is subject to the applicable requirements in 40 CFR 82, Subpart B -  
 26 Servicing of Motor Vehicle Air Conditioners.

27 **5.26.4**       The permittee shall be allowed to switch from any ozone depleting substance to  
 28 any alternative that is listed in the Significant New Alternative Program  
 29 promulgated pursuant to 40 CFR 82, Subpart G - Significant New Alternative  
 30 Policy Program.

33 **5.27           Inapplicable Requirements**

 37 apply to these inapplicable requirements.


