1 **J CONTINGENCY PLAN**

2 The requirements in this Contingency Plan are applicable to waste that is regulated by [WAC 173-303](#)
 3 (e.g. dangerous and mixed waste). Pursuant to [WAC 173-303-350](#)(2), and according to the provisions of
 4 this Addendum J, the Hanford Facility Permit WA7890008967 (Permit) Attachment 4, *Hanford*
 5 *Emergency Management Plan* (DOE/RL-94-02), and the Building Emergency Plan specific to Low Level
 6 Burial Grounds Trenches 31, 34, 94 (LLBG) will be amended to incorporate requirements of [WAC 173-](#)
 7 [303-350](#) and [WAC 173-303-360](#) within 30 days of the effective date of the permit.

8 Table J.1 identifies the sections of the unit-specific building emergency plan written to meet [WAC 173-](#)
 9 [303-350](#)(3) contingency plan requirements identified in this addendum. In addition, Section 12.0 of the
 10 unit-specific LLBG building emergency plan is written to meet [WAC 173 303-350](#) and [WAC 173-303-](#)
 11 [360](#) requirements. Copies of Permit Attachment 4, *Hanford Emergency Management Plan* (DOE/RL-94-
 12 02) and the building emergency plan are located and maintained on the Hanford Facility and available as
 13 identified in Section J.6. Revisions to Addendum J require a Permit modification subject to [WAC 173-](#)
 14 [303-830](#) and Permit Condition I.C.3.

15 The unit specific building emergency plan also serves to satisfy a broad range of other requirements
 16 [e.g., Occupational Safety and Health Administration standards [[29 CFR 1910](#)], *Toxic Substance Control*
 17 *Act of 1976* [[40 CFR 761](#)] and U.S. Department of Energy Orders. Therefore, revisions made to portions
 18 of this unit specific building emergency plan that are not governed by the requirements of [WAC 173-303-](#)
 19 [350](#) and [WAC 173-303-360](#) will not be considered as a modification subject to [WAC 173-303-830](#) or
 20 Permit Condition I.C.3.

21 Any changes to sections of Attachment 4 or the BEP that are governed by the requirements of [WAC 173-](#)
 22 [303-350](#) and [WAC 173-303-360](#) (identified in table J.1) will be provided to Ecology for review to ensure
 23 compliance with the requirements of Addendum J and to determine if a permit modification request is
 24 required.

1 **J.1 Building Evacuation Routing (Building Layout)**

2 Evacuation routing maps will be maintained in the facility operating record and provide identification of
 3 the primary and secondary staging areas and a general layout of the Low-Level Burial Grounds.
 4 Alternate evacuation routes will be used on a case-by-case basis, based on meteorological conditions at
 5 the time of the event.

6 **J.2 Building Emergency Director**

7 The Incident Command System (ICS) and staff, with supporting on-call personnel, will meet the
 8 requirements of the Emergency Coordinator as identified in [WAC 173-303-360\(1\)](#). The Building
 9 Emergency Director (BED) will direct emergency response until the Incident Commander (IC) arrives.
 10 The BED becomes a member of the ICP and functions under the direction of the IC. In this role, the BED
 11 will continue to manage and direct LLBG operations. During events, LLBG personnel will perform
 12 response duties under the direction of the BED. The senior Hanford Fire Department official manages the
 13 Incident Command Post (ICP), unless the event is determined to be primarily a security event, in which
 14 case the Hanford Fire Department and Hanford Patrol will operate under a unified command system with
 15 Hanford Patrol making all the decisions pertaining to security. These individuals are designated as the IC
 16 and as such, have the authority to request and obtain any resources necessary for protecting people and
 17 the environment.

18 A listing of the BEDs by title, work location and work telephone number is contained in Section J.7. The
 19 BED is on the premises or is available through an on-call list 24-hours-a-day. Names and home telephone
 20 numbers of the BEDs will be available from the Patrol Operations Center (POC) in accordance with
 21 Permit Condition II.A.3.

22 **J.3 Implementation of the Contingency Plan**

23 In accordance with [WAC 173-303-360\(2\)\(b\)](#), whenever there is a release, fire, or explosion, the BED will
 24 ensure that trained personnel identify the character, exact source, amount, and areal extent of any released
 25 materials. Identification of waste can be made by activities that can include, but are not limited to, visual
 26 inspection of mixed waste capsules, sampling activities in the field, reference to inventory records, or by
 27 consulting with facility personnel. During the emergency, if samples of materials are required, sampling
 28 will be performed by qualified personnel and the samples will be analyzed as appropriate.

29 The BED will use the emergency procedures of [WAC 173-303-360\(2\)\(d\)](#) to implement an emergency
 30 event:

31 “If the emergency coordinator determines that the facility has had a release, fire, or explosion which could
 32 threaten human health or the environment, he must report his findings as follows:

⁶ The Hanford Facility (site wide) signals are provided in Attachment 4, Table 5.1. LLBG specific communication equipment and warning systems are provided in section J.4.3.

⁷ Evacuation routes for occupied buildings surrounding the DWMUs are posted on information boards within the buildings.

1 (i) If his assessment indicates that evacuation of local areas may be advisable, he must immediately
2 notify appropriate local authorities. He must be available to help appropriate officials decide whether
3 local areas should be evacuated; and

4 (ii) He must immediately notify the department and either the government official designated as the
5 on-scene coordinator, or the National Response Center (using their 24-hour toll free number (800)
6 424-8802).”

7 As soon as possible after stabilizing event conditions, the BED will determine, in consultation with the
8 site contractor environmental single-point-of-contact, if notification to Ecology is needed to meet
9 [WAC 173-303-360\(2\)\(d\)](#) reporting requirements. Additional information is found in Permit Attachment
10 4, *Hanford Emergency Management Plan* (DOE/RL-94-02), Section 4.2.

11 If review of all available information does not yield a definitive assessment of the danger posed by the
12 incident, a worst-case condition will be presumed and appropriate protective actions and notifications will
13 be initiated. The BED will be responsible for initiating any protective actions based on their best
14 judgment of the incident.

15 The BED must assess each incident to determine the response necessary to protect the personnel, facility,
16 and the environment. If assistance from Hanford Patrol, Hanford Fire Department, or ambulance units is
17 required, the Hanford Emergency Response Number (911 from site office phones/373-0911 from cellular
18 phones) must be used to contact the Patrol Operations Center and request the desired assistance. To
19 request other resources or assistance from outside the LLBG, the Patrol Operations Center business
20 number is used (373-3800).

21 **J.3.1 Protective Action Responses**

22 Protective action responses are discussed in the following sections. The steps identified in the following
23 description of actions do not have to be performed in sequence because of the unanticipated sequence of
24 incident events.

25 **J.3.1.1 Evacuation**

26 If an evacuation is ordered or the evacuation siren sounds in the area of the LLBG, personnel will proceed
27 to the staging areas (refer to Section J.1). Evacuation staging areas for the LLBG are specific to the burial
28 ground personnel and are assigned to at the time of the event. Designated signs will be placed at the
29 trailer/building for identification by personnel. The BED will direct personnel to an alternate location as
30 needed.

31 The BED or Staging Area Manager directs evacuations; however, to ensure that evacuations will be
32 conducted promptly and safely, all personnel will be familiar with the correct evacuation procedure.

33 Area evacuations are rapid or controlled, as pointed out in the following steps. When possible, these steps
34 must be performed concurrently.

Area Evacuation Procedure
<ul style="list-style-type: none">• Halt any operations or work and place equipment and structures in a safe condition. Use emergency shutdown procedures for rapid evacuation.
<ul style="list-style-type: none">• Use whatever means are available (portable radios, bullhorns, runners, etc.) to pass the evacuation information to personnel.
<ul style="list-style-type: none">• Evacuate personnel to the staging area; group personnel as follows: potentially contaminated protective clothing, keys immediately available for vehicles, and those needing rides. Assist personnel that are temporary/permanently disabled.
<ul style="list-style-type: none">• Conduct personnel accountability. If unable to account for personnel, report personnel accountability results to the Protective Actions Coordinator in the Hanford-Emergency Operations Center (Hanford-EOC).
<ul style="list-style-type: none">• Inform IC of any potentially affected personnel (i.e., injured, contaminated, exposed, etc.) once the IC arrives at the ICP.
<ul style="list-style-type: none">• Relay pertinent evacuation information (routes, destination etc.) to drivers.
<ul style="list-style-type: none">• Dispatch vehicles as soon as the vehicles are loaded.
<ul style="list-style-type: none">• Report status to the Hanford-EOC, request additional transportation if required, and report if any personnel remain who are performing late shutdown duties.

1 **J.3.1.2 Take Cover**

2 When the Take Cover Alarm is activated, personnel will take cover in the nearest building or trailer.

3 A message followed by the Take Cover siren will be transmitted over the area emergency sirens.

4 Portable, hand-held radios are used throughout the LLBG for communication. The following actions
5 must be taken or considered:

- 6 • Shut doors and windows and wait for further instructions
- 7 • Secure ventilation system
- 8 • Follow normal exit procedures from radiological areas
- 9 • Lock up classified documents and prepare for a possible evacuation
- 10 • Report your location to the Accountability Aid or the BED
- 11 • Accountability Aides will provide accountability status to the Staging Area Manager for LLBG
12 personnel during an event
- 13 • Inform IC of any potentially affected personnel (i.e., injured, contaminated, exposed, etc.) once
14 the IC arrives at the ICP.

15 **J.3.2 Response to Facility Operations Emergencies**

16 Whenever there is an imminent or actual emergency situation, the BED will review the site wide and
17 LLBG emergency response procedure(s) and, as required, categorize and/or classify the event. If
18 necessary, the BED will initiate area protective actions and Hanford Site Emergency Response
19 Organization activation. The steps identified in the following description of actions do not have to be
20 performed in sequence because of the unanticipated sequence of incident events.

21 **J.3.2.1 Loss of Utilities**

22 A case-by-case evaluation is required for each event to determine loss of utility impacts. When a BED
23 determines a loss of utility impact, actions will be taken to ensure dangerous and/or mixed waste is being

1 properly managed. As necessary, the BED will stop operations and take appropriate actions until the
2 utility is restored.

3 • Loss of Electricity. Electricity in the trailers is for lighting, heating, and cooling only. Loss of
4 electricity will not impair functions or constitute an emergency. Electrical power is required for
5 Trenches 31 and 34 of the 218-W-5 Burial Ground operations; however, loss of electricity does
6 not constitute an emergency, but must be restored as soon as possible. Electricity supplies power
7 to the sump pumps used to remove accumulated leachate from the primary and secondary liners.
8 In the event of a loss of electrical power and the leachate accumulation is in excess, a generator
9 will be used to provide temporary power.

10 • Loss of Water - N/A

11 • Loss of Ventilation - N/A

12 • Loss of Steam - N/A

13 • Loss of Air - N/A

14 **J.3.2.2 Major Process Disruption/Loss of Plant Control**

15 N/A

16 **J.3.2.3 Pressure Release**

17 Personnel will immediately evacuate the hazard area. In the event of any injuries, personnel will
18 immediately call 911 from Hanford Site office phones/373-0911 from cellular phones for medical
19 response.

20 **J.3.2.4 Fire and/or Explosion**

21 In the event of a fire, the discoverer will activate a fire alarm (pull box); calls 911 from Site office
22 phones/373-0911 from cellular phones) or verify that the Hanford Emergency Response Number has been
23 called. Automatic initiation of a fire alarm (through the smoke detectors and sprinkler systems) is also
24 possible.

25 • Unless otherwise instructed, personnel will evacuate the area/building by the nearest safe exit and
26 proceed to the designated staging area for accountability.

27 • On actuation of the fire alarm, ONLY if time permits, personnel will shut down equipment,
28 secure waste, and lock up classified materials (or hand carry them out). The alarm automatically
29 signals the Hanford Fire Department.

30 • The BED will proceed directly to the ICP, obtains all necessary information pertaining to the
31 incident and sends a representative to meet Hanford Fire Department.

32 • The BED will provide a formal turnover to the IC when the IC arrives at the ICP.

33 • The BED will inform the Hanford Site Emergency Response Organization as to the extent of the
34 emergency (including estimates of dangerous waste and mixed waste quantities released to the
35 environment).

36 • If operations are stopped in response to the fire, the BED will ensure that systems are monitored
37 for leaks, pressure buildup, gas generation and ruptures.

38 • Hanford Fire Department firefighters will extinguish the fire as necessary.

39 **NOTE:** *Following a fire and/or explosion, [WAC 173-303-640\(7\)](#) will be followed for the less-than-90-*
40 *day Leachate Storage Tank regarding fitness for use.*

41 **J.3.2.5 Hazardous Material, Dangerous and/or Mixed Waste Spill**

42 Spills can result from many sources including process leaks, container spills or leaks, damaged packages
43 or shipments, or personnel error. Spills of mixed waste are complicated by the need to deal with the extra
44 hazards posed by the presence of *Atomic Energy Act* materials.

- 1 • The discoverer will notify the BED and initiate SWIMS response:
 - 2 – Stops work
 - 3 – Warns others in the vicinity
 - 4 – Isolates the area
 - 5 – Minimizes exposure to the hazards
 - 6 – Requests the BED Secure ventilation.
- 7 • The BED will determine if emergency conditions exist requiring response from the Hanford Fire
- 8 Department based on classification of the spill and injured personnel, and will evaluate the need
- 9 to perform additional protective actions.
- 10 • If the Hanford Fire Department resources are not needed, the spill will be mitigated with
- 11 resources identified in Section J.4 and proper notifications will be made.
- 12 • If the Hanford Fire Department resources are needed, the BED will call 911 from Hanford Site
- 13 office phones/373-0911 from cellular phones.
- 14 • The BED will send a representative to meet the Hanford Fire Department.
- 15 • The BED will provide a formal turnover to the IC when the IC arrives at the ICP.
- 16 • The BED will inform the Hanford Site Emergency Response Organization as to the extent of the
- 17 emergency (including estimates of dangerous waste and mixed waste quantities released to the
- 18 environment).
- 19 • If operations are stopped in response to the spill, the BED will ensure that systems are monitored
- 20 for leaks, pressure buildup, gas generation, and ruptures.
- 21 • Hanford Fire Department will stabilize the spill.

22 NOTE: *For response to leaks or spills and disposition of leaking or unfit-for-use tank systems,*
23 *requirements under [WAC 173-303-640](#)(7) will be met.*

24 **J.3.2.5.1 Damaged or Unacceptable Shipments**

25 During the course of receiving dangerous and/or mixed waste at LLBG, an unanticipated event could be
26 discovered resulting in a conformance issue concerning the waste. In some cases, the conformance issue
27 will result from receiving an off-site shipment, manifested pursuant to Permit, Condition II.N.2 or
28 [WAC 173-303-370](#) that is damaged or otherwise presents a hazard and cannot be transported. Damaged
29 or unacceptable shipments resulting from onsite transfers are not subject to [WAC 173-303-370](#); however
30 conformance issues will be resolved in order to maintain proper records.

- 31 • Regardless of whether the waste is received as an off-site shipment or onsite transfer, the
- 32 following actions will be taken:
 - 33 • Operations management will be notified of the damaged or unacceptable waste to be received.
 - 34 • If the conformance issue results in a spill or release, actions described in Section J.3.2.5 will be
 - 35 taken.
 - 36 • The generating organization will be notified of the conformance issue.
 - 37 • An operations representative, in conjunction with the generating organization, will determine the
 - 38 course of action to resolve the conformance issue.

39 **J.3.3 Prevention of Recurrence or Spread of Fires, Explosions, or Releases**

40 The BED, as part of the ICP, will take the steps necessary to ensure that a secondary release, fire, or
41 explosion does not occur. The BED will take measures, where applicable, to stop processes and
42 operations; collect and contain released wastes and remove or isolate containers. The BED will also
43 monitor for leaks, pressure buildups, gas generation, or ruptures in valves, pipes or other equipment,
44 whenever this is appropriate.

1 **J.3.4 Incident Recovery and Restart of Operations**

2 A written recovery plan is needed following an event when the recovery actions could result in further
3 risk to human health or the environment. This written recovery plan will be developed when necessary in
4 accordance with Permit Attachment 4, Hanford Emergency Management Plan (DOE/RL-94-02), Section
5 9.2. Permit Attachment 4, Hanford Emergency Management Plan (DOE/RL-94-02), Section 5.1, also
6 discusses different reports to outside agencies.

7 If the contingency plan was implemented, Ecology will be notified before operations can resume [[WAC](#)
8 [173-303-360\(2\)\(j\)](#)]. This notification must include the following statements.

- 9 • No waste that may be incompatible with the released material is treated, stored, or disposed of
10 until cleanup procedures are completed [[WAC 173-303-360\(2\)\(i\)](#)]; and
- 11 • All emergency equipment listed in the contingency plan is cleaned, and fit for its intended use
12 before operations are resumed [[WAC 173-303-360\(2\)\(i\)\(ii\)](#)].

13 The notification required by [WAC 173-303-360\(2\)\(j\)](#) may be made via telephone conference and
14 documentation of the notification will be included in the WESF operating record. Additional information
15 that Ecology requests regarding these restart conditions will be included in the required 15 day report
16 identified in Section J.5 and required by [WAC 173-303-360\(2\)\(k\)](#).

17 For emergencies not involving activation of the Hanford-EOC, the BED will ensure that conditions are
18 restored to normal before operations are resumed. If the Hanford Site Emergency Response Organization
19 was activated and the emergency phase is complete, a special recovery organization could be appointed at
20 the discretion of RL to restore conditions to normal. This process is detailed in RL and contractor
21 emergency procedures. The makeup of this organization depends on the extent of the damage and the
22 effects. The onsite recovery organization will be appointed by the appropriate contractor's management.

23 **J.3.5 Incompatible Waste**

24 After an event, the BED or the onsite recovery organization will ensure that no waste that might be
25 incompatible with the released material is treated, stored, or disposed of until cleanup procedures are
26 completed pursuant to [WAC 173-303-360\(2\)\(i\)](#). Clean up actions are taken by LLBG personnel or other
27 assigned personnel. Permit Attachment 4, *Hanford Emergency Management Plan* (DOE/RL-94-02),
28 Section 9.2.3, describes actions to be taken.

29 Waste from cleanup activities is designated and managed as newly generated waste. A field check for
30 compatibility is performed before storage, as necessary. Incompatible wastes will not be placed in the
31 same container and will follow the requirements of [WAC 173-303-630\(9\)](#). Containers of waste will be
32 placed in approved storage areas appropriate for their compatibility class.

33 If incompatibility of waste was a factor in the incident, the BED or the onsite recovery organization will
34 ensure that the cause is identified and corrected.

35 **J.3.6 Post Emergency Equipment Maintenance and Decontamination**

36 The BED will ensure that all emergency equipment listed in the J.4 is cleaned and fit for its intended use
37 before operations are resumed in accordance with [WAC 173-303-360\(2\)\(i\)\(ii\)](#). Depleted stocks of
38 neutralizing and absorbing materials will be replenished; protective clothing will be cleaned or disposed
39 of and restocked, etc.

4 include the elements specified in [WAC 173-303-360\(2\)\(k\)](#).
