RE: Coastal Zone Management Consistency Determination for the SR 161 Mashel River
Scour/Slope Repair in the City of Eatonville in Pierce County, Washington.

Dear Mr. Sawyer:

On March 2, 2011, the Washington State Department of Transportation (WSDOT) submitted a Federal Consistency Determination stating that the above project is consistent with the Washington State Coastal Zone Management Program (CZMP). Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, the Department of Ecology (Ecology) concurs with WSDOT's determination that the proposed work is consistent with Washington's CZMP.

You have a right to appeal this determination to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001 (2).

To appeal you must do the following within 30 days of the date of receipt of this Decision:

File your appeal and a copy of this Determination with the PCHB (see addresses below).
Filing means actual receipt by the PCHB during regular business hours.

Serve a copy of your appeal and this Determination on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
