On October 5, 2015, Bellingham Cold Storage submitted a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for maintenance dredging of the Squalicum Waterway, Whatcom County, Washington. The proposed project is to conduct maintenance dredging to restore the navigable depths in Squalicum Waterway at the existing Bellingham Cold Storage facility dock.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with the Glacier NW's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001 (2).

To appeal you must do all of the following within 30 days of the date of receipt of this Order:

- File your appeal and a copy of this Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Order on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
