Below is the 2010 Preliminary Tier Assignment Schedule for Washington's Electronic Product Recycling Program. The purpose of the 2010 Tier Assignment is to determine manufacturer fees owed to the Department of Ecology. These fees are used to cover Ecology's administrative costs for implementing the *E-Cycle Washington* program. The manufacturers listed are those Ecology has identified as the brand owners of electronic products covered by this program (computers, monitors, laptops and televisions).
