

SEPA ENVIRONMENTAL CHECKLIST

Ecology is proposing to revise Chapter 173-351 WAC - *Criteria for Municipal Solid Waste Landfills*. Ecology is proposing to add two hazardous organic constituents to Appendix III of WAC 173-351-990: *2,3,7,8-Tetrachlorodibenzo- p-dioxin* - [CAS 1746-01-6] and *alpha, alpha-Dimethylphenethylamine* [CAS 122-09-8]. This revision is necessary to be consistent with federal rules in 40 CFR Part 258.

The proposal will not increase discharges to the environment. The proposal will increase the number of pollutants monitored in groundwater samples from municipal solid waste landfills where contamination of groundwater has already been confirmed.

The proposal will enhance the likelihood that operators of municipal solid waste landfills identify potential releases of the two contaminants by expanding the list of chemicals required to be monitored after routine monitoring for a standard list of chemicals identifies a statistically significant increase over background levels.

The proposal will not affect plants, animals, fish, or marine life other than it is potentially more protective of the environment.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The proposal will not increase demands on transportation. The proposal will increase the obligation to monitor for potential pollutants in groundwater at the subset of municipal solid waste landfills that have confirmed groundwater contamination. Ecology has identified 25 municipal solid waste landfills in the state. About half have identified groundwater contamination and are engaged in assessment monitoring. Most of the landfills are operated by local governments, but some are operated by the private sector.

Proposed measures to reduce or respond to such demand(s) are:

The proposal is to add two chemicals to an existing list in state rules, consistent with federal rules. The agency considered taking no action, but found that revising the state rule was the best course of action. Revising the state rule will make it consistent with the equivalent federal rules in 40 CFR Part 258, reduce the potential for non-compliance with federal rules, and improve the prospect of identifying two additional pollutants of concern that are not currently monitored under state rules. Ecology prepared a *Preliminary Cost Benefit and Least Burdensome Alternative Analysis* (Ecology publication number 15-07-026) for this rulemaking.

7. Identify, if possible, whether the proposal may conflict with local, state, or federal laws or requirements for the protection of the environment.

The proposal will improve consistency of state rules with federal rules, and is somewhat more protective of the environment. Local jurisdictions that have adopted local ordinances that do not automatically keep up with amendments to the state rule will need to update local ordinances to reflect the addition of the two contaminants.
