Instructions for Applying for Small Business and/or Extreme Hardship Permit Fee Reduction

These instructions cover FY2010 (July 1, 2008 through June 30, 2010) for calendar year 2008.

Any application received for FY2010 cannot be processed until your previous fiscal year account(s) have been paid in full.

Eligibility Requirements

Small Business Fee Reduction Request

A small business holding a permit for an industrial facility may apply for a permit fee reduction. To qualify, a business must meet the following four criteria that define a small business:

1. Be a corporation, partnership, sole proprietorship, or other legal entity formed for the purpose of making a profit.
2. Be independently owned and operated from all other businesses (not a subsidiary of a parent company).
3. Have annual sales of one million dollars (\$1,000,000) or less of the goods and services produced using the processes regulated by the wastewater discharge permit.
4. Pay an annual wastewater discharge permit fee greater than five hundred dollars (\$500).

The permit fee for an eligible small business will be reduced to fifty percent (50%) of the annual permit fee.

Extreme Hardship Fee Reduction Request

If the annual gross revenue of the goods and services produced using the processes regulated by the waste discharge permit is one hundred thousand dollars (\$100,000) or less, and the annual permit fee assessed imposes an extreme hardship, the small business may apply for an extreme hardship fee reduction.

The small business must provide documentation of the amount of sales of the goods and services produced using the processes regulated by the wastewater discharge permit in **calendar year 2008**.

If the sales are subject to taxation under the Washington state business and occupation tax, retail sales tax, or public utility tax, please provide copies of one of the following:

- A complete set of Washington State Department of Revenue Combined Excise Tax Returns for **calendar year 2008**.
- U.S. Corporation Income Tax Return (form 1120).

- Copies of accounting records or receipts may also be submitted in order to identify the sales during the time they were produced using the processes regulated by the wastewater discharge permit.

The permit fee for a small business meeting the extreme hardship criteria will be reduced to the minimum allowed which is \$106.00.

Procedures for Submitting Applications

Holders of wastewater discharge permits for industrial facilities who believe that they qualify for a small business permit fee reduction and/or the small business extreme hardship fee reduction should complete the application in full. Please type or print clearly using ink.

For existing permit holders all applications must be received by the Department of Ecology **no later than September 30, 2008**. For holders of new permits issued during the fiscal year, the application must be submitted no later than forty-five (45) days of the date after the first billing.

Payment of the permit fee is not due until the application for a small business fee reduction has been processed and either allowed or denied.

The application must be signed and dated by:

1. In the case of a corporation, by an authorized corporate officer;
2. In the case of a limited partnership, by an authorized general partner;
3. In the case of a general partnership, by an authorized partner; or
4. In the case of a sole proprietorship, by the proprietor.
